

- I. Declarant desires, pursuant to the applicable provisions of the above-referenced instruments, to exercise its right to expand the Project by recording this Phase 5 Amendment and creating Sunbrook Condominiums Phase No. 5.

NOW, THEREFORE, for the purposes and pursuant to the rights, powers, and authority referred to above, Declarant hereby amends the Phase 1 Declaration, the Phase 2 Declaration, the Phase 3 Declaration, and the Phase 4 Amendment, and each of them, as follows:

- 1. <u>SUBMISSION</u>. The Declarant, owner in fee simple of the property, hereinafter the "Phase 5 Property", particularly described in Exhibit "A" annexed hereto, located in Weber County, Utah, hereby submits the Phase 5 Property, together with the buildings, all improvements, all easements, rights and appurtenants thereunto belonging to the provisions of the act and the Phase 1, 2, 3 and 4 Declarations and Phase 4 Amendment, which are all incorporated herein by reference and made a part hereof, and this Phase 5 Amendment. - 2. <u>UNIT NUMBERS</u>. Units 1 and 2 are the upper units, and Units 3 and 4 are the lower units in Building F. Units 1, 2, 3 and 4 are the upper units, and units 5, 6, 7, and 8 are the lower units in Building G.
- 3. <u>CONDOMINIUM PROJECT</u>. Condominium Project shall mean and refer to the Sunbrook Condominiums Project as a whole, which includes Sunbrook Condominiums Phases 1, 2, 3, 4 and 5, and any additional phases properly annexed to the Project.

- 4. TRACT. Tract shall mean and refer to all real property included in the Project, including the real property of Phases 1, 2, 3, 4 and 5, Sunbrook Condominiums, and any additional real property properly annexed into the Project. The property which Exhibit "A" of this Phase 5 Amendment submits to the terms of the Act constitutes a Tract.
- 5. <u>DESCRIPTION OF IMPROVEMENTS</u>. The improvements included in this Phase of the Project, and all such improvements are described on the Phase 5 Map. The Phase 5 Map indicates the number of stories, the number of units which are contained in the Building which comprises of part of such improvements, the dimensions of the Units, the recreational areas and facilities, if any, and all other Common Areas thereof. This Phase of the Project does now (or will) consist of a total of twelve (12) Units:
 - i. One building consisting of four (4) units and the other building consisting of eight (8) units, for a total of twelve (12) units. Both buildings are two stories in height and are (or shall be) constructed with cement footings and foundations, wood framing and exterior brick veneer, aluminum and stucco siding. All such improvements shall be consistent with the improvements in terms of quality of construction and design as those in Phases 1, 2, 3 and 4.
- 6. <u>EXPANSION OF THE PROJECT</u>. Declarant continues to reserve the right to expand the Project to include additional Phases as permitted in Article III, Paragraph 33, of the Declarations.
- 7. MAXIMUM/MINIMUM NUMBER OF UNITS. If portions of the Additional Land (as described in Exhibit "D" annexed to the Phase 1 Declaration) are added to the Project, each portion of phase may contain no more than twenty-eight (28) units per acre added to the Project. The minimum number of Units in the Project is forty-eight (48) which gives each Unit owner a maximum percentage of interest in the Common Areas and Facilities of 2.08%. The maximum number of Units in the Project, once fully expanded, shall be one hundred forty (140) units which gives each Unit Owner a minimum percentage of interest in the Common Areas and Facilities of .7143%.

With respect to the Percentage Interest in the Project, to avoid a perpetual series of digits and to obtain a total of one hundred percent (100%), the last digit of some Units has been adjusted and rounded up or down to a value that is most nearly correct.
- 9. <u>INVALIDITY</u>. The invalidity of any provisions of this Phase 5 Amendment, or any portion thereof, shall not be deemed to impair or affect in manner the validity, enforceability, or effect of the remainder of this Phase 5 Amendment and, in such event, all of

the other provisions of this Phase 5 Amendment shall continue in full force and effect as if such invalid provision had never been included herein.

- 10. <u>WAIVER</u>. No provision contained in this Phase 5 Amendment shall be deemed to have been abrogated or waived by reason of any failure to enforce the same, irrespective of the number of violations or breaches which may occur.
- 11. <u>HEADINGS</u>. The headings appearing at the beginning of the paragraphs of this Phase 5 Amendment are only for convenience of reference and are not intended to describe, interpret, define, limit, extend, or other affect the content, meaning, or intent of this Phase 5 Amendment or any paragraph or provisions hereof.
- 12. <u>CONFLICTS</u>. This Phase 5 Amendment is set forth to comply with the requirements of the Act and the Phase 1, 2 and 3 Declarations and the Phase 4 Amendment. In event of any conflict between this Phase 5 Amendment and the Phase 1, 2 or 3 Declarations, or the Phase 4 Amendment, the provision of this Amendment shall control. In event of any conflict between this Phase 5 Amendment and the provision of the Act, the provisions of the Act shall control.
- 13. <u>EFFECTIVE DATE</u>. This Phase 5 Amendment shall take effect upon recording in the Office of the County Recorder of Weber County, Utah.
- Amendment and the Phase 1, 2 and 3 Declarations and the Phase 4 Amendment and all the provisions contained therein shall constitute covenants to run with the land or equitable servitudes, as the case may be, and shall be binding upon and shall inure to the benefit of the Declarant, and all parties who hereafter acquire any interest in a Unit, in the Project, and their respective grantees, transferees, heirs, devisees, personal representatives, successors, and assigns. Each Owner or Occupant of a Unit shall comply with, and all interest in all Units, shall be subject to, the terms of the Act, terms of this Phase 5 Amendment, Phases 1, 2 and 3 Declarations, Phase 4 Amendment, the By-Laws, and the provisions of any rules, regulations, and agreements, and failure to comply shall be grounds for an action to recover sums due for damages or injunctive relief, or both, maintainable by the Management Committee on behalf of Unit Owners, or, in a proper case, by an aggrieved Unit Owner. By acquiring any interest in a Unit or in the Project, the party acquiring such interest consents to, and agrees to be bound by, each and every provision of this Phase 5 Amendment and the Phases 1, 2 and 3 Declarations and the Phase 4 Amendment.
- 13. <u>UNMODIFIED TERMS</u>. Unless specifically amended by this Phase 5 Amendment or by any other amendments to the Phases 1, 2 or 3 Declarations, or the Phase 4 Amendment, all other provisions of the Phases 1, 2 and 3 Declarations and the Phase 4 Amendment shall remain the same.

NOW, THEREFORE, for the purposes and pursuant to the rights, powers, and authority referred to above, Declarant hereby amends the Phase 1 Declaration, the Phase 2 Declaration, the Phase 3 Declaration, the Phase 4 Amendment, and the Phase 5 Amendment, and each of them, as follows:

- 1. <u>SUBMISSION</u>. The Declarant, owner in fee simple of the property, hereinafter the "Phase 6 Property", particularly described in Exhibit "A" annexed hereto, located in Weber County, Utah, hereby submits the Phase 6 Property, together with the buildings, all improvements, all easements, rights and appurtenants thereunto belonging to the provisions of the act and the Phases 1, 2, 3 and 4 Declarations and Phases 4 and 5 Amendments, which are all incorporated herein by reference and made a part hereof, and this Phase 6 Amendment. This Phase of the Project is described as Sunbrook Condominiums, Phase No. 6, on the record of survey map recorded simultaneously herewith.
- 2. <u>UNIT NUMBERS</u>. This Phase 6 of the Project consists of four buildings, each containing four separate Units. The Units shall be known as Units 1 through 4, Building H, Units 1 through 4, Building I, Units 1 through 4, Building K.
- 3. <u>CONDOMINIUM PROJECT</u>. The Condominium Project shall mean and refer to the Sunbrook Condominiums Project as a whole, which includes Sunbrook Condominiums Phases 1, 2, 3, 4, 5 and 6, and any additional phases properly annexed to the Project.
- 4. TRACT. Tract shall mean and refer to all real property included in the Project, including the real property of Phases 1, 2, 3, 4, 5 and 6, Sunbrook Condominiums, and any additional real property properly annexed into the Project. The property which Exhibit "A" of this Phase 6 Amendment submits to the terms of the Act constitutes a Tract.
- 5. <u>DESCRIPTION OF IMPROVEMENTS</u>. The improvements included in this Phase of the Project, and all such improvements are described on the Phase 6 Map. The Phase 6 Map indicates the number of Units which are contained in each Building, which comprises part of such improvements, the dimensions of the Units, the recreational areas and facilities, if any, and all other Common Areas thereof. This Phase of the Project will consist of four (4) separate buildings, each containing four (4) separate Units, for a total of sixteen (16) Units. Each Unit is

two stories in height and will be constructed with cement footings and foundations, wood framing and exterior brick veneer, aluminum and stucco siding.

- 6. <u>EXPANSION OF THE PROJECT</u>. Declarant continues to reserve the right to expand the Project to include additional Phases as permitted in Article III, Paragraph 33, of the Declarations.
- AAXIMUM/MINIMUM NUMBER OF UNITS. If portions of the Additional Land (as described in Exhibit "D" annexed to the Phase 1 Declaration) are added to the Project, each portion or phase may contain no more than twenty-eight (28) units per acre added to the Project. The minimum number of Units in the Project is sixty-four (64), which gives each Unit Owner a maximum percentage of interest in the Common Areas and Facilities of 1.51% for the smaller Units and 1.72% for the larger Units. The maximum number of Units in the Project, once fully expanded, shall be one hundred forty (140) Units which gives each Unit Owner a minimum percentage of interest in the Common Areas and Facilities of approximately .7143%., depending upon the size of the Unit.
- 8. <u>COMPUTATION OF PERCENTAGE INTEREST</u>. Each Unit in the Project shall include an undivided interest in the Common Areas and Facilities. The proportionate share of the Unit Owners in the Common Areas of the Project is set forth in Exhibit "B" annexed hereto and made a part hereof. With respect to the Percentage Interest in the Project, to avoid a perpetual series of digits and to obtain a total of one hundred percent (100%), the last digit of some Units has been adjusted and rounded up or down to a value that is most nearly correct.
- 9. <u>INVALIDITY</u>. The invalidity of any provisions of this Phase 6 Amendment, or any portion thereof, shall not be deemed to impair or affect in manner the validity, enforceability, or effect of the remainder of this Phase 6 Amendment and, in such event, all of the other provisions of this Phase 6 Amendment shall continue in full force and effect as if such invalid provision had never been included herein.
- 10. <u>WAIVER</u>. No provision contained in this Phase 6 Amendment shall be deemed to have been abrogated or waived by reason of any failure to enforce the same, irrespective of the number of violations or breaches which may occur.
- 11. <u>HEADINGS</u>. The headings appearing at the beginning of the paragraphs of this Phase 6 Amendment are only for convenience of reference and are not intended to describe, interpret, define, limit, extend, or other affect the content, meaning, or intent of this Phase 6 Amendment or any paragraph or provisions hereof.
- 12. <u>CONFLICTS</u>. This Phase 6 Amendment is set forth to comply with the requirements of the Act and the Phase 1, 2 and 3 Declarations and the Phase 4 and 5 Amendments. In the event of any conflict between this Phase 6 Amendment and the Phase 1, 2 or 3 Declarations, or the Phase 4 and 5 Amendments, the provision of this Amendment shall

control. In the event of any conflict between this Phase 6 Amendment and the provision of the Act, the provisions of the Act shall control.

- 13. <u>EFFECTIVE DATE</u>. This Phase 6 Amendment shall take effect upon recording in the Office of the County Recorder of Weber County, Utah.
- and the Phase 1, 2 and 3 Declarations and the Phase 4 and 5 Amendments and all the provisions contained therein shall constitute covenants to run with the land or equitable servitudes, as the case may be, and shall be binding upon and shall inure to the benefit of the Declarant, and all parties who hereafter acquire any interest in a Unit, in the Project, and their respective grantees, transferees, heirs, devisees, personal representatives, successors, and assigns. Each Owner or Occupant of a Unit shall comply with, and all interest in all Units, shall be subject to, the terms of the Act, terms of this Phase 6 Amendment, Phases 1, 2 and 3 Declarations, Phase 4 and 5 Amendments, the By-Laws, and the provisions of any rules, regulations, and agreements, and failure to comply shall be grounds for an action to recover sums due for damages or injunctive relief, or both, maintainable by the Management Committee on behalf of Unit Owners, or, in a proper case, by an aggrieved Unit Owner. By acquiring any interest in a Unit or in the Project, the party acquiring such interest consents to, and agrees to be bound by, each and every provision of this Phase 6 Amendment and the Phases 1, 2 and 3 Declarations and the Phase 4 and 5 Amendments.
- 13. <u>UNMODIFIED TERMS</u>. Unless specifically amended by this Phase 6 Amendment or by any other amendments to the Phases 1, 2 or 3 Declarations, or the Phase 4 and 5 Amendments, all other provisions of the Phases 1, 2 and 3 Declarations and the Phase 4 and 5 Amendments shall remain the same.





NOW, THEREFORE, for the purposes and pursuant to the rights, powers, and authority referred to above, Declarant hereby amends the Phases 1, 2 and 3 Declarations, and the Phases 4, 5 and 6 Amendments, and each of them, as follows:

- 1. <u>SUBMISSION</u>. The Declarant, owner in fee simple of the property, hereinafter the "Phase 7 Property", particularly described in Exhibit "A" annexed hereto, located in Weber County, Utah, hereby submits the Phase 7 Property, together with the buildings, all improvements, all easements, rights and appurtenants thereunto belonging to the provisions of the act and the Phases 1, 2, 3 Declarations and Phases 3, 4, 5 and 6 Amendments, which are all incorporated herein by reference and made a part hereof, and this Phase 7 Amendment. This Phase of the Project is described as Sunbrook Condominiums, Phase No. 7, on the record of survey map recorded simultaneously herewith.
- 2. <u>UNIT NUMBERS</u>. This Phase 7 of the Project consists of eight buildings, each containing four separate Units. The Units shall be known as Units 1 through 4, Building L, Units 1 through 4, Building M, Units 1 through 4, Building N, Units 1 through 4, Building P, Units 1 through 4, Building Q, Units 1 through 4, Building R, and Units 1 through 4, Building S.
- 3. <u>CONDOMINIUM PROJECT</u>. The Condominium Project shall mean and refer to the Sunbrook Condominiums Project as a whole, which includes Sunbrook Condominiums Phases 1, 2, 3, 4, 5, 6 and 7, and any additional phases properly annexed to the Project.
- 4. TRACT. Tract shall mean and refer to all real property included in the Project, including the real property of Phases 1, 2, 3, 4, 5, 6 and 7, Sunbrook Condominiums, and any additional real property properly annexed into the Project. The property which Exhibit "A" of this Phase 7 Amendment submits to the terms of the Act constitutes a Tract.
- 5. <u>DESCRIPTION OF IMPROVEMENTS</u>. The improvements included in this Phase of the Project, and all such improvements are described on the Phase 7 Map. The Phase 7 Map indicates the number of Units which are contained in each Building, which comprises part of such improvements, the dimensions of the Units, the recreational areas and facilities, if any, and all other Common Areas thereof. This Phase of the Project will consist of eight (8) separate buildings, each containing four (4) separate Units, for a total of thirty-two (32) Units. Each Unit is two stories in height and will be constructed with cement footings and foundations, wood framing and exterior brick veneer, aluminum and stucco siding.
- 6. <u>EXPANSION OF THE PROJECT</u>. Declarant continues to reserve the right to expand the Project to include additional Phases as permitted in Article III, Paragraph 33, of the Declarations.
- 7. MAXIMUM/MINIMUM NUMBER OF UNITS. If portions of the Additional Land (as described in Exhibit "D" annexed to the Phase 1 Declaration) are added to the Project, each portion or phase may contain no more than twenty-eight (28) units per acre added to the

Project. The minimum number of Units in the Project is seventy-six (76), which gives each Unit Owner a maximum percentage of interest in the Common Areas and Facilities of 1.21% for the smaller Units and 1.38% for the larger Units. The maximum number of Units in the Project, once fully expanded, shall not exceed one hundred forty (140) Units which gives each Unit Owner a minimum percentage of interest in the Common Areas and Facilities of approximately .7143%, depending upon the size of the Unit.

- 8. <u>COMPUTATION OF PERCENTAGE INTEREST</u>. Each Unit in the Project shall include an undivided interest in the Common Areas and Facilities. The proportionate share of the Unit Owners in the Common Areas of the Project is set forth in Exhibit "B" annexed hereto and made a part hereof. With respect to the Percentage Interest in the Project, to avoid a perpetual series of digits and to obtain a total of one hundred percent (100%), the last digit of some Units has been adjusted and rounded up or down to a value that is most nearly correct.
- 9. INVALIDITY. The invalidity of any provisions of this Phase 7 Amendment, or any portion thereof, shall not be deemed to impair or affect in manner the validity, enforceability, or effect of the remainder of this Phase 7 Amendment and, in such event, all of the other provisions of this Phase 7 Amendment shall continue in full force and effect as if such invalid provision had never been included herein.
- 10. <u>WAIVER</u>. No provision contained in this Phase 7 Amendment shall be deemed to have been abrogated or waived by reason of any failure to enforce the same, irrespective of the number of violations or breaches which may occur.
- 11. <u>HEADINGS</u>. The headings appearing at the beginning of the paragraphs of this Phase 7 Amendment are only for convenience of reference and are not intended to describe, interpret, define, limit, extend, or other affect the content, meaning, or intent of this Phase 7 Amendment or any paragraph or provisions hereof.
- 12. <u>CONFLICTS</u>. This Phase 7 Amendment is set forth to comply with the requirements of the Act and the Phase 1, 2 and 3 Declarations and the Phase 4, 5 and 6 Amendments. In the event of any conflict between this Phase 7 Amendment and the Phase 1, 2 or 3 Declarations, or the Phase 4, 5 or 6 Amendments, the provision of this Amendment shall control. In the event of any conflict between this Phase 7 Amendment and the provision of the Act, the provisions of the Act shall control.
- 13. <u>EFFECTIVE DATE</u>. This Phase 7 Amendment shall take effect upon recording in the Office of the County Recorder of Weber County, Utah.
- 14. <u>COVENANT TO RUN WITH LAND: COMPLIANCE</u>. This Phase 7 Amendment and the Phase 1, 2 and 3 Declarations and the Phase 4, 5 and 6 Amendments and all the provisions contained therein shall constitute covenants to run with the land or equitable servitudes, as the case may be, and shall be binding upon and shall inure to the benefit of the Declarant, and all parties who hereafter acquire any interest in a Unit, in the Project, and their respective grantees,

transferees, heirs, devisees, personal representatives, successors, and assigns. Each Owner or Occupant of a Unit shall comply with, and all interest in all Units, shall be subject to, the terms of the Act, terms of this Phase 7 Amendment, Phases 1, 2 and 3 Declarations, Phase 4, 5 and 6 Amendments, the By-Laws, and the provisions of any rules, regulations, and agreements, and failure to comply shall be grounds for an action to recover sums due for damages or injunctive relief, or both, maintainable by the Management Committee on behalf of Unit Owners, or, in a proper case, by an aggrieved Unit Owner. By acquiring any interest in a Unit or in the Project, the party acquiring such interest consents to, and agrees to be bound by, each and every provision of this Phase 7 Amendment and the Phases 1, 2 and 3 Declarations and the Phase 4, 5 and 6 Amendments.

13. <u>UNMODIFIED TERMS</u>. Unless specifically amended by this Phase 7 Amendment or by any other amendments to the Phases 1, 2 or 3 Declarations, or the Phase 4, 5 and 6 Amendments, all other provisions of the Phases 1, 2 and 3 Declarations and the Phase 4, 5 and 6 Amendments shall remain the same.
